**Public to Join Pool**

Type C Annual Membership, which includes one (1) adult person that does not reside within the District and is not an authorized Resident Member. Type C Annual Memberships shall run from the date of acceptance of an application for membership by Club Manager until the end of the Club fiscal year, September 30. Annual Membership renewals shall run from the beginning of the renewal Club fiscal year, October 1, to September 30 of the succeeding year. Non-residents are eligible to become Annual Members upon payment of the required Club Fees. Guest Points, as defined below, must be utilized for any additional persons.
